CHARTER OF INCORPORATION

OF

RAMBLEWOOD ESTATES RECREATION
ASSOCIATION, INCORPORATED

The undersigned natural persons, having capacity to contract and acting as Incorporators of a corporation under the Tennessee General Corporation Act, adopt the following charter for said corporation:

1. The name of the corporation is: RAMBLEWOOD ESTATES RECREATION ASSOCIATION, INCORPORATED.
2. The duration of the corporation is perpetual.
3. The address for the principal office for the corporation in the State of Tennessee shall be 43 Ridgewood Cove, Jackson, Tennessee 38301.
4. The corporation is not for profit.
5. The purposes for which the corporation is organized is for the establishing, maintaining, and operating of an association, not for profit, solely for the mutual advantages to be derived therefrom; to present a unified effort by the members of the association in establishing and maintaining recreational facilities in Ramblewood Estates, and to engage in such other activities as may be to the mutual benefit of the owners of the property in Ramblewood Estates, Madison County, Tennessee, including, but not limited to, the development, construction and maintenance of recreational facilities in Ramblewood Estates Subdivision for the use and benefit of members of the association.
