Note - August Lifeguard Schedule: Since school will begin early August, lifeguard hours will change and be posted as school starts.	

IMPORTANT!! Children under the age of 12 must be accompanied by a PARENT or a PARENTALLY DESIGNATED person. The rules are posted at the pool for the safety and enjoyment of all members. Each member and their guests are subject to following the rules set forth. Any member or guest who continuously disregards the pool rules or lists incorrect or false membership information on their membership form may be subject to immediate dismissal from the property or even revocation of swimming privileges. Membership dues are nonrefundable if membership is revoked for any reason.

MEMBERSHIP CARDS: All members will be issued cards and will check in using the new electronic entry system. Guests must register with the lifeguard. Any non-member who enters the fenced area will be asked to pay the guest fee or will be asked to leave the pool grounds.

GUEST FEES: Members may bring a guest besides their permanent guest(s) on their membership card. The fees are \$5 per individual guest or \$15 per family (5 people or less with at least one being an adult). Each guest may visit up to five (5) times during the season. NOTE: Out of town guests may swim free of charge. The permanent guests on your membership CANNOT bring guests. NO RAMBLEWOOD ESTATES RESIDENT may be a guest. Members cannot substitute a guest(s) for their permanent guest(s) on their membership card. If a member needs to revise their permanent guest(s) list, the member needs to submit an email to ramblewood.pool@gmail.com. A new membership card will be issued.

VOLUNTEERS: Much of the work for the pool is performed by volunteers. Help at the pool is welcome and needed! Volunteer opportunities include pool cleaning, chemical and nightly closing checks, bush and tree maintenance, and seasonal opening and closing of the pool.

PARTIES: Only members may have parties at the pool and/or pavilion. Please contact Jill Tanner (731-616-1501) at least two weeks in advance for information about scheduling. There is a lifeguard fee of \$20/hour (must be paid in cash directly to the lifeguard) and a \$50.00 non-refundable deposit for all parties. This can be paid in cash, or a check can be made out to Ramblewood Estates. You are responsible for cleaning up after your party.

TELEPHONE: The telephone is to be used in cases of emergency only.

Types of Memberships:

- A. **Resident Membership:** Individuals or families who own property within Ramblewood Estates Neighborhood boundaries.
- B. **Non-Resident Membership:** Individuals or families who do not own property within Ramblewood Estates Neighborhood boundaries or are renters within the neighborhood boundaries.
- C. **Legacy Membership:** Individuals or families who are the children of a current Resident Member** and live outside the Ramblewood Estates Neighborhood boundaries.

** The Ramblewood Estates Resident Member must be current on the annual Association fees and pool dues for the Legacy member to obtain a swimming membership.
